#### What is Flora & More?

Flora & More is a wholesale only marketplace that offers orchids, select plants, ceramics, glass, other floral products and related supplies and accessories to business members for resale or end use.

The Flora & More marketplace offers special pricing and industry information. It is not open to the general public.

A valid and active membership account is needed to process an order and checkout.

#### How does a business become a Flora & More member?

We have different membership levels based on industry segments, which is determined the application is approved.

To become a member of the Flora & More Marketplace, eligible businesses need to purchase an annual membership ranging from \$250 to \$150 for 2017. The Flora & More membership card is non-transferable, but several cards can be requested for the same account.

Flora & More offers day passes for International or Out of State Customers for \$25.00 (proof of address is needed).

An eligible business must submit a complete Flora & More membership application along with its business license and/or resale certificate in person at our main location: 11500 NW 123rd St Rd, Medley, FL 33178.

# What are the pricing benefits of the Flora & More membership?

Flora & More strives to give our members the best prices for the products we offer. As such, we have negotiated a flat fee (plus applicable sales tax, unless member presents a valid resale certificate) for the products we offer, over which members will pay a surcharge based on the membership type held: Distributor, Garden Center, Designer, and Hospitality.

### How long is my Flora & More membership valid?

Flora & More marketplace memberships are valid for one calendar year. Members who apply after January 5 of the relevant year will pay a prorated annual membership fee based on \$250 or \$150.

Members must notify Flora & More of any changes in ownership, address, or telephone number. If Flora & More is unable to communicate with a member, member buying privileges may be suspended, and eligible businesses will need to reapply to obtain access to the Flora & More products.

## How do I pay at the Flora & More marketplace?

We accept credit cards and cash only and your membership card needs to be presented at the time of checkout. Flora Members are asked to show receipt of purchase when exiting the building.

#### Flora & More Exchanges & Returns Policy

All our sales are FINAL and no returns for any products purchased at the Flora & More marketplace. If you find any item that is not up to our standards, please contact a team member before check out.

We will refund the prorated value left of your membership fee at any time if you are dissatisfied with our products or services.

Containers, backpacks, handbags, briefcases or bags are not allowed in the Marketplace.

Flora Members are responsible for the safe usage of the shopping carts and have the obligation to return the carts to the area specified as well as making sure to avoid carts from becoming an obstacle to traffic flow inside the warehouse and in the parking area.

Smoking is prohibited in Flora & More.

Violation of any of the terms and conditions may result in revocation of your membership.
